FAQ's ABOUT THE BOULDER JUNCTION RECREATION PROGRAM

- 1. When does the program start and finish?** The program traditionally starts the fourth week of June (6/20) and continues for seven weeks, through the first week of August (to 08/04). There is no program on the 4th of July or on Friday, August 5 this year. SCHEDULES ARE NOT AVAILABLE UNTIL MID-JUNE.
- 2. Is lunch provided?** No. Parents or guardians are responsible not only for lunches, but for making sure that any special medications (if applicable), sunscreen, towels and swimsuits or any other equipment (i.e. bicycles and helmets) are provided. The program generally provides arts and crafts materials, unless otherwise indicated.
- 3. How much does it cost?** The full program of seven weeks for **residents and/or taxpayers** costs **\$50** for the first child, **\$40** for the second child and **\$30** dollars for the third child. Any additional child from the same family is free. This fee is required for the full program regardless of how many days a week your child attends. **Non-residents** fees are **\$100** for the first child, **\$80** for the second child and **\$60** for the third child. - 4. Is my child required to attend every day or all daily or outside functions?** NO! Roll call is not taken to make sure of attendance, nor is it required that you phone to say that your child will be absent. IT IS IMPERATIVE, HOWEVER, THAT YOU MAKE ARRANGEMENTS FOR THE DROP OFF AND PICK-UP OF YOUR CHILDREN IF HE/SHE IS NOT FOLLOWING THE DAILY SCHEDULE IN ITS ENTIRETY. [Also see FAQ11](#).
- 5. What if my child's cousin or friend is coming up for a week?** Can he/she participate? Yes. Children may also be enrolled for a day. The registration fee for one day is **\$20 for resident/taxpayer** or **\$30 for non-resident** plus any extra fees (see FAQ6). CHILDREN CANNOT ATTEND WITHOUT SIGNED CONSENT FORMS.
- 6. How much are the extra fees?** Regular, routine daily fees are **\$2.00 CASH**. PLEASE MAKE SURE YOUR CHILD HAS THIS MONEY TO GIVE TO MR. ROEDER. Any special or admission fees are spelled out on the schedule.
- 7. What if it rains on a day something is scheduled for outdoors?** On the schedule you will find a succession of rain day events which will be followed in order unless otherwise indicated. PLEASE READ YOUR SCHEDULE DAILY TO SEE IF THERE ARE ANY SPECIAL FUNCTIONS, HALF-DAY EVENTS OR SPECIAL FEES REQUIRED.
- 8. What happens with field trips?** Sometimes parents are asked to chaperone or may accompany the children if so desired. SIGN-UP BEFORE, AS INDICATED ON THE SCHEDULE, IS MANDATORY. If you don't wish for your child to attend you simply don't sign or show up.
- 9. How old must my child be?** The program is available to those aged 6-14. Age 5 may be permitted but staff prefers that an older sibling also be enrolled. There are *no exceptions* unless approved by Mr. Roeder himself.
- 10. What are the qualifications of Park Staff?** Mr. Roeder is a teacher, coach, and father of eight children who has been running the program for nearly forty years. At a minimum, at least one staff member has taken Wilderness First Aid and Water Safety courses.
- 11. What if I drop off my child early or pick them up late?** THE WELFARE AND SAFETY OF YOUR CHILD OUTSIDE PROGRAM HOURS IS YOUR RESPONSIBILITY. PARK STAFF IS NOT RESPONSIBLE FOR CHILDREN DROPPED OFF EARLY BEFORE STAFF ARRIVES. AFTER PROGRAM HOURS, CHILDREN WILL NOT BE SUPERVISED ONCE THE BUS HAS RETURNED OR THE PROGRAM IS OVER. IT IS THE PARENTS RESPONSIBILITY TO PICK UP THEIR CHILDREN PROMPTLY BY THE END OF EACH DAY'S SCHEDULED ACTIVITIES. PLEASE MAKE ARRANGEMENTS TO HAVE YOUR CHILD SECURED BY AN AUTHORIZED PARTY TO BE DROPPED OFF OR PICKED UP IF YOU ARE NOT ABLE TO DO SO. NEITHER THE TOWN OF BOULDER JUNCTION, NOR THE ROEDER FAMILY IS RESPONSIBLE FOR CONTACTING YOU TO MAKE SURE YOUR CHILD IS SECURED.
